## **PRIVACY STATEMENT**

### **SECTION 1 - YOUR INFORMATION**

What type of information is collected and by whom?

Our company is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our products and services to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

Wix may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page. We may also collect personally identifiable information (including name, email, communications);, product reviews, recommendations, and personal profile

When you browse our store, Wix also automatically receives your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.

We receive, collect and store any information you enter on our website or provide us in any other way. In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet;

Email marketing (if applicable): With your permission, we may send you emails about our store, new products and other updates.

### **SECTION 2 - CONSENT**

How do you get my consent?

When you provide us with personal information to complete a transaction, verify your credit card, place an order, arrange for a meeting/consultation, delivery, or return a purchase, we imply that you consent to our collecting it and using it for that specific reason only.

If we ask for your personal information for a secondary reason, like marketing, we will ask you directly for your expressed consent (double opt-in).

How do I withdraw my consent?

Payment:
